- 1. The candidate must be a citizen of India.
- 2. Pay Structure like Grade Pay, NPA may be relaxed subject to the discretion of Competent Authroity, if requiid.
- 3. The period of Deputation including Short-Term Contract will be initially for 2 years which may be extendable.
- 4. The Details of PG Teaching Experience should be indicated separately in Col. No.9. A Certificate from the Head of the College/Institute concerned certifying that the said College/Institute has the Regular PG Course in the Subject concerned during the period for which the Candidate claims PG Teaching Experience. In the absence of such a Certificate, the PG Experience claimed will not be treated as PG Experience.
- 5. Any experience gained on part-time basis, daily wages, visiting/guest faculty will not be considered as a valid experience.
